The transfer of admission for regular student will be admissible only from institutions which are already accorded provisional recognition and affiliation (Erstwhile permitted/Recognition) to another affiliated institution.

The students may submit their applications through online for transfer of admission in to HS 2^{nd} Year Class by visiting https://coi.ahseconline.in or www.ahsec.assam.gov.in. The concerned students and institutions are advised to go through the given guidelines/SOP, important dates etc. in detail for compliance and smooth conduct of the transfer process.

Applicable fee is given below-

- Rs. 600/- (Non-refundable application fee) (For ASSEB, DIV-II students only).
- Rs. 1300/- (Non-refundable application fee) (For Students from Other Boards as enlisted on the portal).

Note:

- 1. The fee for students from other board includes the application fee of Rs. 600 + Registration fee of Rs. 400 (including late fine) + Eligibility Fee of Rs. 300/-.
- 2. As the entire process of transfer is online, hence, physical attendance of student in this office relating to this matter are not allowed.

The admission on transfer is facilitated to only the regular students who has passed the Higher Secondary First Year Examination 2025 and is admissible only from institutions which are already accorded provisional recognition and affiliation (Erstwhile permitted/Recognition) to another affiliated institution. (Student from other Board/Council as enlisted on the portal can also apply).
- 2. TRANSFER OF A STUDENT SHALL BE CONSIDERED GENERALLY ON THE FOLLOWING GROUNDS-

A.	TRANSFER OF PARENTS IN SERVICE	In case of transfer of parents in service, attested copy of order of transfer from competent authority and certified joining report from the controlling officer after joining the new place of posting is to be submitted/uploaded.			
В.	UNAVOIDABLE CHANGE OF RESIDENCE OF PARENTS.	In case of unavoidable change of residence of parents (in the event of death of parent, copy of death certificate has to be submitted/ uploaded). In this connection a certificate is to be submitted/uploaded from the concerned revenue authority where from transfer is sought.			
C.	MEDICAL GROUND.	If transfer is sought on medical ground, a medical certificate from competent authority is required to be submitted/uploaded.			

Note: The Council may consider case(s) other than those mentioned above depending on the merit.

- 3. THE MODE OF SUBMISSION OF APPLICATION AND PAYMENT OF FEE- Apply Online through Portal <u>Link-https://coi.ahseconline.in</u>
- **4.** Application shall be considered if subject(s) proposed by the student is / are permitted in the recognized / permitted institution of the council to where transfer is sought.
- 5. Transfer will be allowed to the registered and eligible students only.
- 6. Application for transfer will not be considered if the institution falls within the same city/town area except in medical ground.
- 7. All subjects currently studying by the student in the present institution must needs to be available in the admission seeking institution. If any elective subjects are not available in the admission seeking/New Institution, then the students have to submit a declaration for not appearing the subject is mandatory. (For ASSEB, DIV-II Students Only).
